## **1. PART 1 - GENERAL**

### **1.1 Interpretation**

In the licence, terms are as defined in Section 1, 64 and 157 of the Marine Scotland Act 2010, and

- a) "**the 2010 Act**" means the Marine (Scotland) Act 2010;
- b) "**Licensed Activity**" means any activity or activities listed in section 21 of the 2010 Act which is, or are authorised under the licence;
- c) "**Licensee**" means MOWI Scotland Limited
- d) "**Mean high water springs**" means any area submerged at mean high water spring tide;
- e) "**Commencement of the Licensed Activity**" means the date on which the first vehicle or vessel arrives on the site to begin carrying on any activities in connection with the Licensed Activity;
- f) "**Completion of the Licensed Activity**" means the date on which the Licensed Activity has been installed in full, or the Licensed Activity has been deemed complete by the Licensing Authority, whichever occurs first;

All geographical co-ordinates contained within the licence are in WGS84 format (latitude and longitude degrees and minutes to three decimal places) unless otherwise stated.

## **1.3 Other authorisations and consents**

The Licensee is deemed to have satisfied itself that there are no barriers or restrictions, legal or otherwise, to the carrying on of the Licensed Activities in connection with the licensed activity. The issuing of the licence does not absolve the Licensee from obtaining such other authorisations and consents, which may be required under statute.

## **1.4 Variation, suspension, revocation and transfer**

Under section 30 (1) of the 2010 Act the Licensing Authority may by notice vary, suspend or revoke the licence granted by them if it appears to the Licensing Authority that there has been a breach of any of its provisions. For any such other reason that appears to be relevant to the Licensing Authority under section 30(2) or (3) of the 2010 Act. Under the 2010 Act variations, suspensions, revocations and transfers of licences are subject to the procedures set out in section 31 of the Act.

Under section 30 (7) of the 2010 Act, on an application made by a licensee, the Licensing Authority may vary a licence if satisfied that the variation being applied for is not material.

Under section 30 (8) of the 2010 Act, on an application made by the licensee, the Licensing Authority may transfer the licence from the Licensee to another person.

## **1.5 Breach of requirement for, or conditions of, licence**

Under section 39 of the 2010 Act it is an offence to carry on a Licensable Marine Activity without a marine licence and it is also an offence to fail to comply with any condition of a marine licence.

## **1.6 Defences: actions taken in an emergency**

Under section 40 of the 2010 Act it is a defence for a person charged with an offence under section 39(1) of the 2010 Act in relation to any activity to prove that –

the activity was carried out for the purpose of saving life, or for the purpose of securing the safety of a vessel, aircraft or marine structure ('force majeure'), and

that the person took steps within a reasonable time to inform the Licensing Authority as set out in section 40(2) of the 2010 Act.

### **1.7 Offences relating to information**

Under section 42 of the 2010 Act it is an offence for a person to make a statement which is false or misleading in a material way, knowing the statement to be false or misleading or being reckless as to whether the statement is false or misleading, or to intentionally fail to disclose any material information for the purpose of procuring the issue, variation or transfer of a marine licence or for the purpose of complying with, or purporting to comply with, any obligation imposed by either Part 4 of the 2010 Act or the provisions of this licence.

### **1.8 Appeals**

Under Regulation 3(1) of the Marine Licensing Appeals (Scotland) Regulations 2011 a person who has applied for a marine licence may by summary application appeal to against a decision taken by the Licensing Authority under section 71(1)(b) or (c) or (5) of the Act.

### **2.3 Description of the Licensed Activity**

Variation to an existing finfish farm at Camus Glas, Loch Sunart.

As described in application dated 24 June, 2020 and correspondence submitted in support of the application.

### **2.4 Descriptions of the substances or objects to be deposited**

This licence authorises the deposit of the undernoted substances and objects required in connection with the licensed activity, subject to the maximum amounts as specified below:

The Marine Farm must consist of:

The total number of permitted cages must be: 12

The total number of permitted grid moorings must be: 21

The total number of permitted marked buoys must be: 63

The total number of permitted associated boat moorings must be: 4

The total number of permitted rafts must be: 1

The total number of permitted feed barges must be: 1

### **3. PART 3 – CONDITIONS**

#### **3.1 General Conditions**

3.1.1. The Licensee must at all times deposit substances and objects in accordance with the licence, the application and the plans and programmes approved by the Licensing Authority.

3.1.2. The Licensee must ensure that only the licensed objects are deposited during the execution of the Licensed Activity and that all substances or objects deposited during the execution of the Licensed Activity are inert and do not contain toxic elements which may be harmful to the marine environment, the living resources which it supports or human health.

3.1.3. The Licensee must ensure that the Licensed Activity does not encroach on any recognised anchorage, either charted or noted in nautical publications, within the licensed area.

3.1.4. In the event of any breach of health and safety or environmental obligations relating to the licensed activity during the period of this licence, the Licensee must provide written notification of the nature and timing of the incident to the Licensing Authority within 24 hours of the incident occurring. Confirmation of remedial measures taken and/or to be taken to rectify the breach must be provided, in writing, to the Licensing Authority within a period of time to be agreed by the Licensing Authority.

3.1.5 The Licensee must notify Source Data Receipt, The Hydrographic Office, Admiralty Way, Taunton, Somerset, TA1 2DN (e-mail: sdr@ukho.gov.uk; tel.: 01823 484444) prior to commencement of the Licensed Activity to permit the promulgation of maritime safety information through the national Notice to Mariners system and on Completion of the the Licensed Activity supply a copy of the licence, and wherever possible, 'as built plans', in order that all necessary amendments to nautical publications are made.

3.1.6. If it is desired to display any marks or lights not required by the licence then details must be submitted to the Northern Lighthouse Board and its ruling complied with. The display of unauthorised marks or lights is prohibited.

3.1.7. The Licensee must remove the Licensed Activity from below the level of Mean High Water Springs, or such alterations made, within one month of notice being given by the Licensing Authority at any time it is considered necessary or advisable for the safety of navigation, and not replaced without further approval by the Licensing Authority. The Licensee shall be liable for any expense incurred.

3.1.8. If governmental assistance is required (including UK governmental assistance or the assistance of any UK devolved government) to deal with any emergency arising from:

- a) the failure to mark and light the licensed objects as required by this licence;
- b) the maintenance of the licensed objects; or
- c) the drifting or wreck of the licensed objects,

to include the broadcast of navigational warnings, then the Licensee is liable for any expenses incurred in securing

such assistance.

3.1.9. The Licensee must ensure that a copy of this licence is given to each contractor appointed to carry out part or all of the Licensed Activity in order that they are clear about the extent of the Licensed Activity for which the licence has been given and the conditions that are attached to the licence.

3.1.10. The Licensee must adopt measures to prevent the introduction and spread of invasive non-native species as a result of the Licensed Activities.

3.1.11. Should the Licensee proceed to undertake the Licensed Activity under the authority of this licence, the licensed activity authorised under the previous marine licence in favour of Marine Harvest (Scotland) Limited, dated 23 December 2016 (licence number 06080/16/0) is not permitted.

### **3.2 Prior to the commencement of the Licensed Activity**

3.2.1. The Licensee must provide the name and function of any agent, contractor or sub-contractor appointed to undertake the Licensed Activities, as soon as is reasonably practicable prior to the Licensed Activities commencing.

3.2.2. The Licensee must ensure that only those agents, contractors or sub-contractors notified to the Licensing Authority are permitted to undertake the Licensed Activity.

3.2.3. The Licensee must, prior to and no less than seven calendar days before the Commencement of the Licensed Activity, notify the Licensing Authority, in writing, of the date of Commencement of the Licensed Activity authorised under this licence.

3.2.4. The Licensee must ensure that HM Coastguard, in this case nmoccontroller@hmcg.gov.uk, The National Maritime Operations Centre is made aware of the Licensed Activity prior to Commencement.

3.2.5. The Licensee must issue local notification to marine users - including fisherman's organisations, neighbouring port authorities and other local stakeholders - to ensure that they are made fully aware of the activity.

### **3.3 During the Licensed Activity**

3.3.1. The Licensee must ensure that the Licensed Activity is maintained at all times in good repair.

3.3.2. Only those persons acting on behalf of, and authorised by, the agent or the Licensee shall undertake the deposit operations.

3.3.3. The Licensee must ensure that any debris or waste materials arising during the course of the Licensed Activity are removed for disposal at an approved location above the tidal level of Mean High Water Springs.

3.3.4. In the event of the Licensed Activity being discontinued the Licensed Activity shall be removed and the site cleared to the satisfaction of the Licensing Authority.



3.3.5. Any person authorised by the Licensing Authority must be permitted to inspect the Licensed Activity at any reasonable time.

3.3.6. The Licensee must ensure that copies of the licence are available for inspection by any authorised Enforcement Officer at:

- a) the premises of the Licensee;
- b) the premises of any agent acting on behalf of the Licensee; and
- c) site of the Licensed Activity

3.3.7. The Licensee must ensure that:

- a) The site is marked with 2 lit yellow poles fitted with a yellow 'X' topmark.
- b) Each light displays a character of flash one yellow every five seconds (Fl Y 5s) with a nominal range of 2 nautical miles and be installed above the 'X' topmark.
- c) The poles are positioned at the Western and Eastern seaward corners of the cage group.
- d) Each light is 1 meter above the site equipment handrails and installed to be clearly seen by vessels approaching from all navigable directions.
- e) Poles are greater than or equal to 75mm diameter, the 'X' topmark should be greater than or equal to 75cm length by 15cm width.
- f) The feed barge exhibits an all-round fixed white light with a nominal range of 2 nautical miles from a point at least 1 meter above any other obstruction.

3.3.8. The Licensee must ensure that the navigation marking and lighting given in condition 3.3.7 are installed at the same time as the licensed objects and continued unless and until the Licensing Authority rescind this direction.

3.3.9. The Licensee must ensure appropriate steps are taken to minimise damage to the foreshore and seabed by the Licensed Activity

3.3.10. The Licensee must ensure the foreshore and seabed is returned to the original profile, or as close as reasonably practicable, following the Completion of the Licensed Activity.

3.3.11. The Licensee must ensure the best method of practice is used to minimise re-suspension of sediment during the Licensed Activity.

### **3.4 Upon Completion of the Licensed Activity**

3.4.1. The Licensee must ensure that a weekly check of the Licensed Activity's marking and lighting equipment is made and records kept of its physical state for audit purposes.

3.4.2. The Licensee must, no later than 14 days following the Completion of the Licensed Activity notify the Licensing Authority, in writing, of the date of the Completion of the Licensed Activity.

3.4.3. The Licensee must submit a written report regarding the correct deposit of the licensed objects to the licensing authority. The written report must be submitted on the forms provided by the licensing authority no later than 31 July 2027.

3.4.4. If a new licence is required, the Licensee must make an application at least fourteen weeks before the expiry date of this licence. This licence shall not continue in force after the **expiry date of 22 December 2022**.
