## 1. Introduction

This Pre-Application Consultation (PAC) Report has been prepared by NIRAS Group UK Ltd (NIRAS) on behalf of Peterhead Port Authority (PPA), (the 'Applicant'). The applicant will be submitting two marine licence applications, a marine construction licence application, and a marine dredging and disposal licence application to Marine Directorate Licensing Operations Team (MD-LOT) in relation to the extension of the Smith Quay, Peterhead (the 'Proposed Development').

The PAC Report presents the stakeholder engagement and consultation undertaken, and will be submitted to support the Marine Construction licence application in line with the requirements of the Marine Licensing (Pre-application Consultation) (Scotland) Regulations 2013 and Marine (Scotland) Act 2010: Section 24.

The intention to apply for a marine licence was conveyed through a request for an EIA Screening Opinion. On 18<sup>th</sup> July 2024, Marine Directorate provided a Screening Opinion under the Marine Works (Environmental Impact Assessment) (Scotland) Regulations 2017. In formulating the Screening Opinion, MD-LOT consulted with:

- Aberdeenshire Council
- Historic Environment Scotland (HES)
- NatureScot, and
- Scottish Environment Protection Agency (SEPA).

The screening opinion has also been made publicly available through the [Marine Scotland Information](#) website.

## 2. Pre-application consultation report

### 2.1 Proposed Licensable Marine Activity

Peterhead Port Authority (PPA) propose an up to 85 m extension to the western end of the existing 120 m long Smith Quay, Peterhead Port (see location in Appendix 1 - Project location). The works planned for this extension comprise:

- Demolition of the concrete deck of an existing berthing dolphin, with the dolphin's supporting tubular steel piles cut-off at bed level and removed;
- Partial demolition of a concrete wing wall at the west end of the existing quay;
- Removal and re-use of revetment rock armour adjacent to the west end of the existing quay;
- Quay extension comprising a concrete deck supported on tubular steel piles;
- Rock revetment beneath the quay extension;
- New mooring dolphin comprising a concrete deck supported on tubular steel piles;
- New/repurposed steel access bridge spanning between quay extension and new dolphin;
- Deck furniture;
- Area of reclamation; and
- Capital dredging to enlarge the existing berth pocket.

## **2.4 Pre-application Consultation Event**

In line with Regulation 7 of the of the Marine Licensing (Pre-Application Consultation) (Scotland) Regulations, PPA published in a local newspaper a Public Notice detailing the licensable marine activity for which the licence is to be sought and the pre-application consultation event. The Public Notice was published in the Buchan Observer on 2<sup>nd</sup> September 2025 and a copy is provided at Appendix 2 - Public Notice. To enhance publicity for the event, the notice was issued to two additional regional newspapers: The Ellon Times and Inverurie Herald, and Fraserburgh Herald.

On 2<sup>nd</sup> September 2025, notification of the Pre-application Consultation was additionally given to:

- Aberdeenshire Council;
- Northern Lighthouse Board (NLB);
- The Maritime and Coastguard Agency;
- The Scottish Environment Protection Agency;
- NatureScot; and
- Peterhead Community Council.

Each recipient was provided with an information package (see Appendix 3 – Information package) , and a copy of the Public Notice, which explained when and how to engage and provide feedback. A copy of the notification emails and the NLB response received is included at Appendix 4 – Notification letters and responses.

The Pre-application Consultation event was held at the Palace Hotel, Prince Street, Peterhead, AD42 1PL between 16:00-19:00 on Wednesday 15<sup>th</sup> October 2025. Two representatives from the PPA and three from NIRAS represented the project to address potential engineering, environmental, and other queries.

No members of the local community or stakeholders attended the event.

Images from the event are available at Appendix 5 – Pre-application Consultation images.

Information was provided on the environmental impact assessments and supporting studies completed, as well as regulatory and licensing requirements.






Smith Quay (ringed in yellow) has been operational since 2010, with a 120m long quay and adjacent working area. The Port Authority has proposed extending the western end of Smith Quay by up to 85m.

The current Smith Quay is limited in its ability to berth larger vessels and handle the heavier operating equipment used today.

The port redevelopment has the potential to bring a range of benefits to people in the Aberdeenshire area


## Smith Quay Extension


Smith Quay (above) and the proposed design (below)

Rock Armour Revetment



## Marine Mammals

Construction activities like dredging, piling, and vessel movement create underwater noise. Underwater noise modelling was completed, and an impact assessment undertaken. The construction activities may temporarily disturb marine mammals, but the effects will be short-term and minor.

The harbour is already a busy area, although seals are familiar visitors. The impact assessment has concluded that the level of disturbance will be small and localised to the immediate area of the harbour, with no expected impacts to the wider marine area.

The activity with the highest potential to affect marine mammals is piling. Precautionary measures will be applied to ensure that disturbance is minimised and any risk of injury avoided (see right).



### We're Reducing Risks to Marine Mammals

Protected cetacean species such as porpoise and dolphins are unlikely to occur in the harbour, but to avoid impacts we will:

- Monitor a safety zone before any piling works start.
- Use soft start to gradually increase underwater noise from piling to give animals time to move away.
- Record all observations and report to statutory authorities.



## Seabirds



A number of seabird species regularly or occasionally visit and make use of the harbour for feeding or resting, but the area of works does not support any known nesting habitat. Although birds are used to a busy port environment, some short term and localised disturbance is expected. However, the project site is a small proportion of the harbour area and negligible compared to the overall foraging ranges of seabird species. No significant impacts are expected.



## The sea and its bed



A remotely operated vehicle (ROV) was used to inspect the seabed within and around the proposed work site.

The seabed here consists of a combination of stony and finer sandy sediments, along with some larger rocks, likely remnants of previous construction and rock revetment activities. The area is quite disturbed and supports limited epifauna (animals living on the seabed).

There will be some habitat loss and disturbance beneath the quay expansion itself. Most of this area comprises artificial structures and sandy sediments, which are considered to have low ecological value.

Dredging works will mobilise finer sediments into suspension. There is no significant contamination present in these sediments and although disturbed sediments will temporarily settle on nearby habitats these areas are not highly sensitive and are expected to recover quickly.

## Bathing Water and Marina Use

The works will take place about 1 km away from the marina and Lido area. Most sediment stirred up by dredging will settle back to the seabed well before it could reach the marina/lido area, and the enclosed entrance will limit the amount of finer (silty) sediments which enter.

Low levels of contamination, potentially originating from fuel or lubricant, were detected in one surface sediment sample from the dredging area. There was no contamination in the sub-surface samples, and the impact assessment concluded that dredging will only mobilise contaminants that could be disturbed under natural events, e.g., storms.

Noise from construction and dredging works may be heard from the marina/lido and surrounding areas, but given the distance and location within a busy harbour environment, this is not expected to cause significant disturbance or loss of amenity.

A construction Environmental Management Plan will be in place to minimise the impact of the project activities.

## Licencing and Regulation



To ensure legal compliance and that environmental impacts are understood and minimised, the following are being undertaken in support of, or in parallel with, the Marine Licence application:

- Habitats Regulations Assessment for European Protected Sites
  - Environmental Appraisal (impact assessment)
  - Marine Planning and Policy statement
    - Marine Noise Registry application
    - Dredging and disposal licence

Other permissions, such as a Harbour Revision Order, as necessary.
