To ensure a precautionary assessment of disturbance, the most recent abundance and density estimates from the SCANS surveys have been applied for all cetacean EPS confirmed in the nearshore survey area. A conservative EDR of 3 km has been adopted for non-impulsive geophysical sources, corresponding to a potential disturbance area of approximately 28.3 km². Applying SCANS densities to this area provides a worst-case estimate of the number of individuals potentially exposed during survey operations.

The geophysical survey campaigns are scheduled to take place between June 2026 and June 2028, with the preferred operational window falling between June and October 2026. These surveys within Scottish waters will cover an approximate survey area of 441.87 km², where 84.23 km² will fall within the offshore area. The proposed nearshore survey activities may include the use of multi-beam echo sounders, side scan sonar, magnetometer and sub-bottom profilers. Only the high frequency SBP systems proposed for the works, including CHIRP and parametric SBPs, and the USBL have the potential to injure or disturb marine mammals; however, injury is assessed as negligible considering an individual would need to be within 2m of the sound sources which is considered highly unlikely. While the surveys may generate temporary and localised underwater noise, any disturbance to EPS is expected to be minor and short-lived. A small proportion of individuals within the local population may experience behavioural responses; however, these effects will not result in population-level impacts. To ensure compliance with the Habitats Regulations, an EPS Licence for disturbance is being sought.

This mitigation strategy applies to SBP operations only. Other proposed geophysical sources are assessed as having negligible risk of injury to EPS and therefore do not require mitigation. Measures are based on JNCC (2017) guidelines and include marine mammal observers, a 30-min pre-survey search of a 500m mitigation zone, soft-start procedure and operational controls (e.g., power down/shut down equipment during line turns, vessels will maintain a survey speed of approximately 4 kts, adherence to SMWWC (2017)).

The proposed geophysical survey will deliver significant long-term environmental, economic, and social benefits. The geophysical surveys are required to further investigate the seabed conditions within the Survey Area in order to inform design development and associated environmental assessment. Environmentally, the transmission of renewable energy will contribute to national and international targets to significantly reduce carbon emissions. Economically, the project underpins major infrastructure investment, creates jobs, and facilitates affordable, secure energy supply. Socially, it strengthens energy security and contributes to climate resilience, benefiting communities across the UK. While short-term benefits include employment during survey and construction phases, the primary advantages are long-term, delivering substantial environmental gains and supporting national and international climate commitments.

What public interest will be served? Who will benefit from the proposed activity? Does the proposed activity address a need?

The proposed activity serves a clear public interest by enabling the development of critical energy infrastructure that supports the UK's transition to net zero. It addresses an urgent national need to increase transmission capacity for renewable electricity, particularly offshore wind, from Scotland to areas of high demand in England. This will benefit the public by improving energy security, reducing carbon emissions, and supporting affordable, sustainable energy supply. Wider beneficiaries include households, businesses, and communities across the UK, as well as the offshore wind industry and the economy through job creation and investment. By facilitating progress on legally binding climate targets, the activity delivers long-term environmental and social gains of national and international significance.

Why is it imperative the proposed activity goes ahead?

Without these surveys, the project cannot progress through consenting and design stages, delaying or preventing delivery of essential infrastructure that supports legally binding net-zero targets, energy security, and climate resilience. The primary objective of the geophysical survey is to collect detailed seabed data to inform the optimal placement of the cable route. This includes determining water depths, mapping seabed morphology, identifying natural features such as pockmarks and anchor scars, and assessing shallow geological conditions. The survey will also locate potential hazards, including man-made objects and unexploded ordnance (UXO), which could affect installation safety. In addition, the survey will provide seabed characterisation data to guide the selection of geotechnical and environmental sampling locations. These data will support the Environmental Baseline Survey and facilitate ground-truthing for future habitat assessments.

The activity fulfils a statutory role by enabling compliance with planning and environmental assessment requirements for the EGL4 interconnector project. The geophysical survey provides essential data for route planning, environmental impact assessment, and risk management, ensuring the project can proceed lawfully and safely in accordance with regulatory standards.
