## **Moray East Development Cable Plan**

The Scottish Fishermen's Federation, on behalf of the 400 plus vessels in membership of its 8 constituent associations is pleased to comment on the proposed cable plan from the Moray East Development.

Referring to chapter 4 the SFF would express concern about the time where the cable may end unprotected on the seabed over the summer of 2021 and would expect at the very least, local fishing vessels are employed as guard vessels in mitigation for the temporary loss of access, which is not mentioned in the plan and contradicts GP2, 3, 4, 18 and F1 and 2.

Moving to chapter 5 the plan needs to elaborate and clarify how the MEMC and contractors will interact to avoid conflict with fishing to comply with GP4, 17, 18 and F1 and 2.

In chapter 7.3 discussing EMF, the only data is from a desktop study, which is not sufficient proof, the real effect needs to be measured and monitored.

The SFF are perplexed that chapter 9 does not appear to consider fishing activity as a constraint, this is in contradiction of GP1, 4, 17, 18, 19 and F1, F2 and 3. Proper communication with local fishers is the best way to access knowledge of the seabed and work towards co-existence.

The cable plan chapter 10 is lacking in an assessment of the risk to fishing of the cable, which is in contradiction of GP4, 17, 18 and F1, 2 and 3.

The SFF would expect chapter 11 to be more specific of the impacts of all forms of route clearance to provide more clarity on the safety aspects for the fishing industry, as per GP4, 18 and 18, F1, 2 and 3.



The section on mechanical protection needs clarity on methods appropriate to each area according to the prevailing fishing activity. Full burial is the gold standard and advice has been given to the developers on mattresses, rock dumping, rock bags etc. SFF would further expect the plan to assess the use of GRP constructions which are becoming common in the Oil and Gas industry. This is all needed in order to comply with GP1, 4, 17 and 18, F1, 2 and 3.

Finally referring to the consent condition as quoted in chapters 12 and 13 which included "methodologies for our trawl surveys of the inter-array cable throughout the operational life of the windfarm where mechanical protection of cable land on the seabed is deployed", is not addressed adequately. The use of the phrase "over trawl surveys COULD be employed", is a clear attempt to downgrade the condition from mandatory to optional.

## Dear Redacte,

Thank you for the consultation below requesting comments on the Moray East Offshore Wind Farm Cable Plan (CaP). We note that the wind farm CaP covers the intra-array cables together with, to a more limited extent, the Offshore Substation Platform (OSP) interconnector cables. Both the intra-array cables and the OSP interconnector cables will be engineered and installed by a single contractor. The export cables are covered in the Offshore Transmission Infrastructure (OfTI) CaP, which we have not yet commented on.

Please find below our comments on the wind farm CaP:

- 1. In section 8.5 UXO survey and clearance it mentions that a UXO survey has been conducted but does not present the survey results. We are currently being consulted on a Marine Licence and European Protected Species licence application for UXO clearance.
- 2. A cable burial risk assessment has been undertaken and is presented in section 10. The minimum cable burial depth is between 0.6 0.7m depending on seabed substrate. The installation contractor has a target depth of 1m for all intra-array and OSP interconnector cables across the Moray East site. This is consistent with the Moray East ES 2012. A target depth of 1m should be sufficient to mitigate any electromagnetic fields (EMF). EMF from the cabling will not be greater than baseline (i.e. the earth's magnetic field) and will not give rise to any significant impacts on fish or benthic interests.
- 3. We agree that there will be no changes to the predicted impacts (assessed as minor) from the proposed trencher.
- 4. The total intra-array cable length has decreased from 572km (assessed in the Moray East ES 2012) to approximately 173km. This means that any potential impacts caused by trenching, such as seabed disturbance and suspended sediment, will be reduced.
- 5. We may have further comments to make on the OfTI CaP when submitted.

We hope these comments are useful.
