Global Energy Nigg Ltd – Marine License MS-00009031 (Dredging) Request for a Screening Opinion

We write on behalf of our Clients, Global Energy Nigg Ltd, to formally request a screening opinion under The Marine Works (Environmental Impact Assessment) (Scotland) Regulations 2017 for the above-named project. The screening request relates to the proposals to increase the volume of dredged material to be disposed of at Sutor's Point from 150,000m³ (as stipulated in Condition 2.4 of the above noted license) to 200,000m³.

As required by Paragraph 10 of the above Regulations we have provided a report for this proposal (attached) which includes:

- a) a description of the location of the proposed works, including a plan sufficient to identify the area in which the works are proposed to be sited;
- b) a description of the proposed works, including in particular
 - a list of all of the regulated activities which are proposed;
 - a description of the physical characteristics of the proposed works and, where (ii) relevant, works to be decommissioned; and
 - a description of the location of the proposed works, with particular regard to the environmental sensitivity of geographical areas likely to be affected;
- c) a description of the aspects of the environment likely to be significantly affected by the proposed works; and
- d) a description of any likely significant effects, to the extent of the information available on such effects, of the proposed works on the environment resulting from either, or both, of the following:-
 - (i) the expected residues and emissions and the production of waste, where relevant;
 - (ii) the use of natural resources, in particular soil, land, water and biodiversity.
- (3) A request for a screening opinion may, in addition to the information required in accordance with paragraph (2), also be accompanied by a description of any features of the proposed works or proposed measures envisaged to avoid or prevent significant adverse effects on the environment.
