This application is to increase the pens held on site from 100m circumference to 120m circumference pens within the existing 75m matrix. The number of pens will be increased from 12 to 14 by filling in the existing matrix gap between the two groups, as such there will be no change to the moorings grid or extent of the mooring from the existing site and therefore negligible impact on navigation.

The site will continue to be lit and marked as per The Northern Lighthouse Board's recommendations. The NLB are consulted by the Local Planning Authority as part of the planning process.
