**THE ELECTRICITY WORKS (ENVIRONMENTAL IMPACT ASSESSMENT)
(SCOTLAND) REGULATIONS 2000 (AS AMENDED)**

Further to the notice that DP Marine Energy Ireland Limited (DPME) (Company Number 456838 – Mill House, Buttevant Co. Cork, Ireland) has applied to the Scottish Ministers under Section 36 of the Electricity Act 1989 to construct and operate an offshore tidal array located approximately 6 km off the Rinn of Islay centred on latitude 55.65°N and longitude 6.60°W. The installed capacity of the proposed generating station will be 30 MW

Notice is hereby given that additional information (in the form of a statutory consultee response from the Scottish Environment Protection Agency, Scottish Natural Heritage and Argyll and Bute Council) has been received by Scottish Ministers on this application. Copies of this information have been forwarded to Argyll and Bute Council to be made available for public inspection (along with Argyll and Bute Council's response) by being placed on the planning register.

The Marine Scotland Licensing Operations Team process applications under The Marine (Scotland) Act 2010, the Marine and Coastal Access Act 2009 and the Electricity Act 1989. During the consultation process letters of representation can be sent to Scottish Ministers in support of or objecting to these applications.

Should Scottish ministers call a Public Local Inquiry (PLI), copies of these representations will be sent to the Directorate of Planning and Environmental Appeals for the Reporter to consider during the inquiry. These representations will be posted on their website with address (home and email), signature and home telephone number redacted (blacked out).

Copies of representations will also be issued to the developer on request, again with address (home and email), signature and home telephone number redacted.

You can choose to mark your representation as confidential, in which case it will openly be considered by Scottish Ministers and will not be shared with the Planning Authority, the developer, the Reporter (should a PLI be called) or any other third party.
