Details:

Beatrice offshore windfarm is a development in the Moray Firth of 84 wind turbines and associated offshore transmission works.

As part of conditions 3.2.3.1 of the OWF Marine Licence (number: 04462/18/1), BOWL had no more than one month following the Date of Completion of the Works to notify MS-LOT, in writing.

On 11 July 2019, BOWL submitted a letter requesting MS-LOT to discharge the condition 3.2.3.1 of the OWF Marine Licence ("the discharge request letter") following the end of the construction period (Appendix A). In the discharge request letter, BOWL reported that the Date of Completion of the Works was 14 May 2019.

The discharge request letter was submitted nearly two months after the Date of Completion of the Works and MS-LOT had not received any other notification from BOWL in regard to this date, which lead to the breach of the aforementioned OWF marine licence condition.

However, MS-LOT is satisfied with the discharge request letter to notify MS-LOT on the Date of Completion of the Works. MS-LOT is of the opinion that even though the notification of the

Date of Completion of the Works was delayed, the evidence submitted is sufficient and there is no further action required.

Actions Taken by BOWL:

1. BOWL submitted a discharge request letter on 11 July 2019 and notified MS-LOT of the Date of Completion of the Works.

The final wind turbine generator (WTG), BE-M10, was installed 14<sup>th</sup> May 2019. This is the date of completion of the Works.


